CSQ STUDENT DECLARATION

- I understand the CSQ program commences on 01/10/22 and finishes on the 30/09/23
- I understand that I am eligible for skills assessment and gap training against one eligible qualification per program period.
- I consent to noble training releasing my personal information to CSQ for the purposes of administering the funding program.
- I consent to CSQ contacting me for the purpose of but not limited to:
 - a) a review and
 - b) conducting destination surveys
 - c) for the purpose of advising a Participant of construction Skills Queensland products and services, whether current or future.
- I am aware that the SAGT general construction program consists of:
 - a) funding for one (1) skills assessment and
 - b) a minimum of two (2) and up to eight (8) units of competency of gap training.

To be eligible for the SAGTG program I understand that I must meet the following eligibility:

1. must be

- a) an Australian or New Zealand citizen, or permanent resident, or
- b) a visa holder with relevant permission to work (this does not include international student visas)

2. must be:

- a) an Eligible Worker; Employed in Queensland within the Building & Construction Industry; or
- b) self-employed in Building & Construction Industry; or
- c) an unemployed eligible worker (unemployed for period not greater than 4 years who would otherwise meet the requirements of an Eligible Worker; and
- d) able to demonstrate RPL experience in 70% or more competencies required to complete the full qualification.

3. must

- a) permanently reside in Queensland, or be permanently employed in Queensland

4. must not be

- a) an apprentice or trainee
- b) Through direct credit, achieve more than 50% of the 70% of the units required to meet the demonstrated experience
- c) An employee of an authority*NB – a current exemption applies to Employees of local councils only if they are undertaking duties for building and construction work which would meet the eligible worker criteria
- d) Currently enrolled and participating in another CSQ SAGT or Higher Qualifications program in the same contract term with the exception of the Certificate III in Waterproofing
- e) Currently enrolled and participating in a school program
- f) Contracted as a trainer and assessor or an existing worker of an RTO
- g) Already funded by an Authority or other such source for delivery of the same training being undertaken as part of the relevant program
- h) Participant seeking a verification of competency.
